# INDEPENDENT MARKETING GROUP CONFERENCE: 2024

## Official Qualification Requirements

<b>Eligibility</b>	<b>The Top 80 Qualifiers.</b> Licensed representatives of the Company who qualify in accordance with the official requirements are eligible for an invitation to attend. The licensed representative must be contracted and in good standing with the Company at the time the conference is held.
<b>Qualification Period</b>	<b>January 1, 2023 through December 31, 2023.</b> Applications must be issued and paid (all issue requirements satisfied) by the final cutoff date of December 31, 2023. A minimum life persistency of 80% is required on all business placed during the qualification period and continuing in force through January 31, 2024.
<b>Qualifications</b>	<ol style="list-style-type: none"><li><b>\$100,000+ of Conference Credit AND</b></li><li><b>12 New Cases</b> (General Agent and Agent levels)</li></ol> <p><b>Variable products are not eligible for conference credit.</b> Conference credit is based upon the following formula:</p> <ul style="list-style-type: none"><li><b>100%</b> On paid Life business up to commissionable target first-year premium and (except as noted below) last survivor policies.</li><li><b>5%</b> For paid Individual Annuities.</li><li><b>5%</b> For paid Group Annuities.</li><li><b>5%</b> For first-year Single Premium UL.</li><li><b>10%</b> For Universal Life Excess.</li></ul> <p>Standings are reported on in-force business, and conference credits are not assignable. The company reserves the right to amend the annuity conference credit if any Department of Labor restrictions on compensation on qualified annuities sales go into effect.</p>

## What to Expect in 2024:

<b>Invitation</b>	Conference attendance is available only to those who qualify and are invited by the Company to attend. A guest must be accompanied by the qualifier in order to attend the conference and must be <b>18 years of age or older</b> .  An individual who qualifies and receives an invitation and who, for any reason, is unable to attend the conference is not entitled to any other compensation, nor may the qualifier substitute in his/her stead any other person.
<b>Expenses</b>	Federal/state income tax incurred as a result of attending the conference is the responsibility of the qualifier. A 1099 in the amount of the "fair market value" of the trip will be issued. It is suggested that participants consult their tax advisor in regard to tax treatment. American National will provide: <ul style="list-style-type: none"><li>Air transportation and transfers from the nearest major airport to and from the conference destination</li><li>Taxes and tips necessary to complete the included portions of the conference</li><li>Hotel accommodations</li><li>Specified meals</li><li>Expenses for Tour/Activity sponsored by American National</li></ul>

All additional travel expenses must be paid in full by the participant prior to the conference.
