This document outlines draft recommendations to acute care facilities in this Commonwealth regarding patient weights and provides for a 30-day public comment period. The Patient Safety Authority is responsible for submitting recommendations to the Department of Health for changes in health care practices and procedures which may be instituted for the purpose of reducing the number and severity of serious events and incidents. Once approved by the Department, the Authority is responsible for issuing guidelines to acute care facilities in this Commonwealth. These draft guidelines were approved by both the Authority's Board of Directors and the Secretary of Health. See the instructions for submitting comments at the end of this document.
