### **Multi-insured Discount Increases**

Starting January 1, 2021, the discount will increase from 5% to 7% for new and current members enrolled in a modernized AARP Medicare Supplement Plan (original plan effective dates as of June 1, 2010 and later).

Filed for 7% in: AL, CT, GA, HI, ME, NH, NV, OR, RI, TN, UT, WA

### **New Value-Added Services**

#### **Dental Discounts**

Effective January 1, 2021, all members will get discounts that average 30% to 40% on cleanings, exams, fillings and crowns from a network of 30,000 general dentists and specialists.

**Note:** This may not be available in New York.

### **AARP Smart Driver™ Course**

Effective July 1, 2020, members can brush up on the rules of the road online or in-person at no additional cost. Course completion may qualify for auto insurance discounts. 2

These are additional insured member services apart from the AARP Medicare Supplement Plan benefits, are not an insurance program, are subject to geographical availability and may be discontinued at any time.

### **New 2021 Billing Cycle**

Dependent upon state approval, UnitedHealthcare will be adjusting the annual billing cycle in 17 states to the following:\*

**States with new billing cycle change June to May each year:** AZ, CA, CO, FL, IL, IN, KY, LA, MI, MO, NC, NM, OH, PA, SC, VA, WV.

### State with new billing cycle change for July to June each year: TX

This means members in the impacted states will see their 2020 premium rates continue for an additional five months! And, members will not see any new rate increases during that time (excluding discount wear-offs).

New 2021 rates will start on June 1, 2021. Impacted members were notified of this change in their annual billing cycle change letter, which began to mail in September.
