New Producer Bay Delegation Process

Effective November 11, 2021, you will be able to authorize another person, known as a delegate, from your staff or a business partner* to process and manage your life insurance business in Producer Bay. We are also including a security feature which will require you to reauthorize your delegates every 90 days.

After authorization, your delegate can:

- Create quotes
- Order and download administrative forms and marketing materials
- Check application status or view inforce cases
- Upload requirements and forms on existing cases
- · Check producer licensing and appointment status
- View commission statements (optional permission)

*Your contracted producers are not eligible to become a delegate. They will need to register for their own account with their producer code number.





- Enter the delegate's email address
- Select any additional permissions you would like them to have (if you have access to Planned Performance Tracking or Lifeline, you will also see those options).
- After you add a delegate, they will receive a registration email. Once the delegate registers, they can begin assisting you.



Security Feature

To help prevent unauthorized access, you will need to **reauthorize your delegates every 90 days.**Reminder emails will be sent to you prior to your delegate's access expiring with a link to the reauthorization location. You will also receive a pop up reminder message after logging on to Producer Bay.
